Discussion/Action Items

 Discuss and consider taking action regarding the employment and compensation of the Fire Chief:

The Board entered executive session at 6:37pm pursuant to section 551.074 of the Government Code.

The Board exited executive session at 7:53pm and resumed regular open session. No action was taken during executive session.

Bruce Mills made a motion to end Troy Wenzel's employment with Travis County ESD 8 as of June 28, 2023. The Board extended a non-negotiable offer of 3 months' salary at the base pay and for Troy Wenzel's PTO to be paid out in accordance with the Employee Handbook. If Troy Wenzel accepts these terms the Board would recognize this separation as a retirement. Becky Wynn second the motion. The motion passed unanimously.

President Debra Opdahl asked Troy Wenzel if he was willing to accept this offer. Troy Wenzel asked for the offer to be in writing.

Becky Wynn motioned for Kevin Mullen to formalize the motion and deliver it to the Board President Debra Opdahl. Bruce Mills seconded the motion. The motion passed unanimously.

Kevin Mullen confirmed that he will prepare the separation agreement and deliver to President Debra Opdahl. President Debra Opdahl will then email the agreement to Troy Wenzel.

Troy Wenzel asked if he didn't accept the offer was he fired?

President Debra Opdahl stated as of today you are no longer employed with Travis County ESD 8.

Troy Wenzel stated that he would get paid his 500 hours of PTO. Kevin Mullen clarified the motion reflects that the amount to be paid out would be per the employee handbook.

Kevin Mullen asked for Troy Wenzel's hire date.

President Debra Opdahl asked Troy Wenzel if he had any other questions.

Troy Wenzel asked for the reason for his termination.

President Debra Opdahl stated the Board made it clear in the last meeting, the Board has decided to move in a more positive direction.

Troy Wenzel asked for a timeline on the written offer.

Kevin Mullen will provide the written offer by the end of the week. President Debra Opdahl confirmed the email address with Troy Wenzel.
