Members of the public will speak on agenda items before Board consideration of item. Members of the public who wish to speak on agenda items or make a public comment must complete speaker cards prior to the beginning of the Board meetings;

 - d. Acknowledging and approving posting of "Notice about 2023 Tax Rates" and "Notice of Public Hearing on Tax Increase" to home page of District website.
