3. Public Comment on Agenda items: Individual members of the public may address the Board for a maximum of three minutes per person per agenda item. Individuals may address the Board once per item. Members of the public will speak on agenda items before Board consideration of item. Members of the public who wish to speak on agenda items or make a public comment must complete speaker cards prior to the beginning of the Board meetings;

5. Discuss and consider taking action regarding 2023 tax rate, including;
  - a. Establishing proposed tax rate;

  - d. Acknowledging and approving posting of "Notice about 2023 Tax Rates" and "Notice of Public Hearing on Tax Increase" to home page of District website.
