"I move that the property tax rate be increased by the adoption of a tax rate of \$0.08100, which is effectively is a 6.98 percent increase in the tax rate." Charles Valadez seconded the motion.

A record vote was then taken.

Motion passed unanimously.

Debra Opdahl moved to adopt the Order Levying taxes as written for FY 2023/2024 and authorize filing the order with the Travis County Tax Assessor/Collector. Charles Valadez seconded the motion. A record vote was then taken.

The Order Levying Taxes was then signed and notarized.

Debra Opdahl made a motion to authorize website posting that complies with legal requirements. The motion was seconded by Charles Valadez. A record vote was then taken.
