- Emergency operations, response times, call volume.
  - January
    - 56 Medical calls
      - o 1 traumatic fall which was an open ulna fracture
      - 2 cardiac arrest
      - 2 strokes. One was transported via Starflight
      - o 2 vehicle rescues. One was transported via Starflight
    - Training
      - Continuing to build level specific CEs for each medical member of the organization
      - Implementing credentialing task books into a new software for new hires
        - This is being regionally implemented with our medical director and DCPE
      - Firefighter Bushnell presented:
        - FF Bushnell reported that she passed the National Registry of Emergency Medical Technicians certification on September 20, 2023
        - Advanced Life Support program was attended in October 2023 and was she was cleared in December 2023 to practice as an intermediate EMT
          - This was achieved through clinical scenarios, skills, COGS, medication instructions

- In January, she utilized her paramedic skills on a vehicle rescue in our district.
- Received hands-on training with Starflight and their medics.

The Board thanked Firefighter Paige Bushnell for her continued learning and commitment to the department's medical mission. The Board also thanked EMS Coordinator Clayton Blount for his strides in our medical mission and for being in the forefront of cutting-edge technology with our partners.
