The board directed staff to recategorize items to professional services or administrative cost. That change was made. Category 5075 Professional Services will be reflected in Budget 2025-2026.

Staff asked the board for direction on renaming 2 line items. Annual banquet and recognition. A discussion was had.

The Board directed staff to rename annual banquet to Employee recognition and recognition to Acknowledgement/appreciation.

Capital Outlay-

Staff worked to organize Capital outlay from the budget workshop. Staff removed repairs and remodel of station 802 and increased the amount to replace squad 803.

Debra Opdahl asked that staff work with the district's attorney to change the language for the remodel/expansion of station 801 to a district facilities remodel and expansion Debra also asked that staff work with the attorney to include a bid alternative for the future board meetings that will include options for repairs at station 802.

Boat 801 options are still being explored which include repairs/refurbishment, a temporary loaner boat, or purchase of another boat. The \$275,000 is what staff recommends within the budget to meet the district's needs for a boat.

The Board thanked staff for their hard work and requested updates on the boat options as they become available.

The board also thanked staff for answering their questions and suggestions from the budget workshop. No other questions were asked.
