Notice is hereby given that a meeting of the Board of Commissioners of Travis County Emergency Services District No. 16 will be held on **Wednesday, August 20, 2025, at 5:00 pm.**, at Station 801, located at 801 Bee Creek Road, Spicewood, Texas 78669, for the following purposes:

1. Call meeting to order. Pledge of Allegiance.
2. Public Comment: Members of the public may speak for up to three (3) minutes regarding general topics or specific agenda items. In accordance with the Texas Attorney General's opinion, any public comment that is made on an item that is not on the published final agenda will only be heard by the Board of Commissioners. No formal action, discussion, deliberation, nor comment will be made by the Board of Commissioners.
3. Public Comment on Agenda items: Individual members of the public may address the Board for a maximum of three minutes per person per agenda item. Individuals may address the Board once per item. Members of the public will speak on agenda items before the Board consideration of item. Members of the public who wish to speak on agenda items or make a public comment must complete speaker cards prior to the beginning of the Board meetings.

5. Take a record vote on the District's 2025 tax rate, adopt an Order Levying Taxes, authorize filing the Order with the County Tax Assessor/Collector; and
6. Acknowledge and approve posting of statement regarding adopted tax rate to home page of District website; OR
7. Announce the date, time and place of the meeting to vote on the tax rate;
8. Approval of minutes from 7/23/2025, 7/30/2025, and 8/5/2025 Board Meetings;
9. Receive report from Director of Administration and consider taking related action, including:
 - a. Approval of monthly bills, invoices, and checks, including processing of payroll;
 - b. Approval of financial report;
 - c. Review and approve quarterly investment report;
 - d. Discuss and consider approval of a resolution regarding removing authorized access and signatories for District Texpool account; and
 - e. Discuss and consider approval of a resolution regarding removing authorized access and signatories for bank accounts with Plains Capital;
10. Receive monthly Fire Chief report and consider taking appropriate action;
 - a. Emergency operations, response times, call volume
 - b. Medical Calls
 - c. Training
 - d. Strategic Planning Update;
11. Receive the monthly President's report and consider taking related action;
12. Discuss agenda, time, and date for next meeting; and
13. Adjourn.
